1st Day of 14 / November / 2017.

17 - CAN -035- The year two thousand September 10, quartet tenth and quinz th day of November there was a regular meeting of the board of directors of the Medical Institute Christian of Kasai , " IMCK « Acronym in the IMCK Guest House Meeting Room in Tshikaji, Kananga in Central Kasai under the moderation of Reverend Pastor Jean Tshidinda Mamba . Started at 15h 6min by a hymn number 148 followed by a small meditation drawn in the book of 1Jean 3 : 3-9 by Reverend Pastor Elie Kongo , IMCK Chaplain , whose theme is : **"Our**

heart is the temple of God or reign love, kindness, peace, happiness etc. " a prayer was said by the moderator to put an end to this first part.

V. QUORUM VERIFICATION AND VALIDATION OF MANDATES

17 - CAN - 036 - The quorum having been largely reached, ie 12 people 15, the mandate validation was effective , which allowed the Chairman of the Board to open the work of the Board of Directors in November 2017.

17 - CAN - 037 - The Administrator Kastin Katawa Ntumba was elected Rapporteur of the meeting.

VIII MESSAGE FROM THE CHAIRMAN

17 - CAN - 039 - The President began by imploring our Lord to bless all the participants and welcome them to the Tshikaji resort.

Before getting into the heart of his message, he explained the reasons for the change of dates for this meeting, which is linked to the program of Dr Larry Representative of the PCUSA who will lead a large delegation of DFID who arrives the days already planned for the meeting . According to him it is useless to hold a meeting without the representative of the

PCUSA because the IMCK is the son of three communities to know : The 31th CPC, the 27th Mennonite Community and the CPUSA.

Before closing he asked the participants to look at the facts because the IMCK is shaken, agitated and traumatized out of his satisfaction by the different socioeconomic and political facts. As a result, he guided participants to the wish and wishes by formulating his following concerns. :

1. That the Board becomes aware that a serious crisis in the island elected Domic IMCK, then how the CA will consider determine the role it must play and s s responsibility he must assume,
2. That the CA has the courage not to be afraid to go against the current and break with any philosophy and approach when they obstruct the path of development ,
3. That the CA is forced to have a mind that helps to see the signs of time and to interpret them in order to take the precautions at the appropriate time,
4. That the Board make sure that the resolutions it will have to take are an effective enterprise to curb and solve the crisis by interpreting the words of an author who says " when an event unpleasantness happens to you instead of complaining or getting angry and wasting your energy coldly consider the situation and tell yourself what could I do to make this hard blow the starting point for something better and how to go about bouncing and turning this boredom into an advantage ?

It is through these concerns above that the moderator opened the board meeting of November 2017 and wished everyone a good success .

IX READING OF THE CA MEETING OF MAY 11-12, 2015.

17 - CAN - 040 - After reading by the secretary of the minutes of the meeting of 08-09 May 2017 , it was adopted as the working tool nevertheless some corrections and amendments following :

1. In the minutes the secretary did not return the part which shows the observation of a minute of silence in memory of the late General Secretary Reverend Pastor Mulumba Mukundi Musumbu who died in March 2017-
2. The Board of Directors of PV to be sent on time to all members to analyze and highlight the major decisions in tim, and not to a category of members
3. The Board thanks the hospital collection committee but insists that the IMCK external agents appointed by the Board be actively participate . What is the calendar for the days recovery is developed and given to everyone for the descent on the ground .
4. In the May 2017 PV, the name of ambulance donor is John Tshibuabua Tshitenge and not John Tshitenge. A great deal of discussion took place regarding the transport of this IMCK ambulance which is dragging on in Kinshasa and several proposals were made among others :
 - Seek a competition from OCHA, cfr Head of Health Division
 - To evaluate the cost of river and rail transport from Kinshasa to Ilebo and Ilebo-Kananga,
 - Seek assistance from Monusco .

At this point, the honorary chairman the representative of the CPUSA, was formed in members having a container material of IMCK is underway and will make an effort to pay for the transportation to Tshikaji in record time and the Board has recommended to the IMCK management to thank the donors.

5. Regarding the status of the ISTM TSHIKAJI according to the request of the Director General, the CA considered unnecessary for the ISTM to have its own status as it is a department of the IMCK and has nothing to do with a status it must operate under the responsibility of the IMCK which already has a status and a legal personality.

6. The Board recommended to the management of the IMCK to notarize the PV and request the recognition of current leaders of the IMCK by the State of the appointment of Dr Serge MAKOLO KAZADI Medical Director of IMCK, Mr Kastin KATAWA NTUMBA Administrator Manager of IMCK and Mr MULAMBA KALAMBA Chief of Staff of IMCK .,
7. The appointment of chief study center wasn 'made at the board meeting of the month of May this appointment depends on the position and is the chaplain of the IMCK and not another person.
8. IMCK account signatories must be notified and change the signatures to the BCDC at the end of this meeting.

After all these amendments the minutes of the meeting of the board of directors from 8 to 9 May were adopted as an instrument of work.

X. EVALUATION OF LEVEL OF EXECUTION OF RECOMMENDATIONS OF MAY 2017 BOARD OF DIRECTORS

17 - CAN - 041 - The secretary of the council passed in e reviewed the recommendations of the Board of the month but in 2017 sister 25 recommendations of the meeting of 8 to 9 May 2017, 19 were executed and 6 are renewed, ie 76% of execution . The 6 unfulfilled recommendations were renewed namely ;

1. Select from 3 audit houses, one that can do better the external audit of funds received for a period of 4 years 2013, 2014, 2015 and 2016 in accordance with international standards
2. Contact MBF for the revival of the PAACS project
3. Contact PCUSA and AIMA in order to plan the surgeon who will replace Dr. Fletcher as soon as he reaches the end of his term but is waiting for his replacement : request the extension of his mandate within the IMCK as a surgeon.
4. Have the new hire sign the riders before signing the contract
5. Contact MBF for planning the purchase of parts of the IMCK hydroelectric dam.
6. Contact the American doctor for making prostheses and orthoses s

NB ; Regarding the signature of endorsement, it is not said that only new employees but all employees working within the IMCK whether new or old, workers on fixed or indefinite period.

For the rehabilitation of two pavilions in the IMA account, the honorary president who is at the same time the Director of the IMA specified that his project tends towards the end but the steps are outstanding for the extension and it is in this period that renovation work will resume.

X I. PRESENTATION OF ACTIVITY REPORT FROM THE FIRST 9 MONTHS OF 2017

17 - CAN - 0 42 The nine-month report of 2017 presented by the Director of the IMCK was adopted as an instrument of work after the following amendments and remarks :

Page 6 must present the data as compared month statistics per month for a period of three years in ting to make a clear comparison and know the progress

P. 8 must replace officers leaving the IMCK s directly for a good Functioning as replacing officers is the prerogative of the management of the IMCK and not a problem of the Board ; this only deals with the problem of recruitment of doctors .

P. 9, the fact that 9 month workers are not paid for 5 months for 2016 and 4 months for the first 10 months of 2017 has made many interpretations in the fief of members of the board of directors, but the CA asks IMCK management to do its best to reduce the number of months of non- payment

P. 9 the care of workers' children must depend on certain criteria , the age limit of which must be 18 years for those who do not study and 25 years for those who study . These must present their certificates of schooling before taking charge. The children of workers who apply for the refresher course at the hospital do not have to pay the fees, they have a guarantee from their parents.

P.9 Regarding the difficulty of transporting staff, we are asking management to combine an effort to repair the two broken down vehicles that will facilitate the task of transporting personnel instead of spending a lot of money on the public transport.

P.9 The Board recommends to the management of the IMCK to combine a lot of efforts to finish the pensioners' file and does not want this file to come back again to the Board ,

P.9 With regard to the proposal to amend certain articles of the IMCK's company regulations , the Board agrees and requests that there be consultation between the management of IMCK, the inspection of the the joint union as preliminary and present the result to the next Council for adoption,

P.10 The CA agrees that the CPC Counsel represents the IMCK in justice in the event of a judicial problem and this in collaboration with the legal representative of the IMCK and the management must agree in advance with the counsel for the modality of remuneration.

P.11 At each Board meeting must emphasize the number of people converted by the chaplain for a definite period instead of s stop the number of prayer sessions.

P.12 It is necessary that the direction of the IMCK prepares the endorsements and have them signed by everyone who works within the IMCK because it is a very important document for a good walk of a Christian institution .

P.13 All contentious files of the IMCK must be prepared and submitted to the Representative Legal of IMCK for their treatment.

P. 14 As regards the participation of the biblical IMCK group conference hospitals, the Board asked management to send people concerned in the month of August 2018 for participation.

P. 17 Regarding the reports of our educational institutions, they must be presented concerning the period covered.

GENERAL REMARKS :

Before adopting the nine-month service delivery report, members made the following comments: ;

1. The Board found that the majority of members are from non-health care , so a very small percentage of physicians on the IMCK Board,
2. It must present the screws i received and your reasons within the IMCK for the period covered,
3. We must mention gifts received in the report and specifying the donors,
4. The report presented is partial because there are no data from the Tshikaji Health Zone, so it is necessary to incorporate the essential data of the Zone,

At 20h 52 min intervened e the recess of the meeting after the prayer by Pasteur Tshipamba Mulamba Rev.

2nd Day Wednesday, November 16, 2017

The resumption of the meeting with prayer by Elder Lawrence Kamizelo, monitoring e a meditation from the book of Genesis 4 ; 1-5 by the Chaplain of the IMCK whose theme is " To take the image of Abel by appearing before God with a heart of kindness ". The final prayer was told by Reverend Pastor Tshipamba Mulamba to close this first part of the day

XI I READING FINANCE COMMITTEE Minutes

17 - CAN - 043 - Taking the floor , the Chief Accountant of the IMCK read the minutes of two meetings of the Finance Committee held on August 30, 2017 and the one of November 13, 2017 at PAX. These two were approved PV com s me an instrument of work after the remark following amendment s and s :

- 1) Regarding the lawyer's assignment for the recovery to our subscribers insolvent, the e CA adheres to the management decision to terminate all the steps ahead Preliminaries of certification and file insolvent records with the representative law for the assignment of lawyers in collaboration with the management of the IMCK .
- 2) In the financial report the CA recommends to the management of the IMCK to be specific numbers and do not use etc. in the report ;
- 3) At the next meeting ; management is asked to present the list of insolvent customers that some members can handle to present to the politico-administrative authorities for an adequate solution ;
- 4) With regard to the audit, the Board recommends that management move quickly with the process as the audit takes place for the years 201 2 -2016
- 5) The absence of the President in two meetings of the finance committee was related to an unavailability and trip he made outside the country and not voluntary.
- 6) It should specify that the second accountant was appointed in accordance with the decision of the Board on behalf of heart Monsie François Lupongo in our finance committee ;
- 7) Regarding the situation of other accounts outside the DRC will require the presence of Mr. Larry for accuracy ;
- 8) The IMCK has paid a deposit of \$ 2,500 on \$ 10,000 from Maitre Albert for the service rendered since 2013 despite the various means of claims used

XII I THE PRESENTATION OF THE ECONOMIC-FINANCIAL SITUATION OF IMCK

17 - CAN - 044 - Head co mptable by speaking presented the first detailed report of the financial condition of nine months beginning with the state treasury of our banks ; BCDC ; TMB ; WELLS FARGO ; CASH AND ECO ; the table of funds received was presented without forgetting the operating account compared to the budget through the statements of debts and debts.

After reading, the following amendments and comments were noted :

P.9 The Board regrets that not all the external members of the collection committee went to the field to participate in the recovery. ; he recommends that they surpass themselves for the interest of the community

P.10 the Board noted that the charity fee has helped the IMCK to reduce the load of the staff but the months of now they are at 9 so it is recommended to the management of the IMCK to make an effort to reduce the months of non-payment within the IMCK despite the low revenues. The numbers of charity cases have increased following the events of the last two years but the planned amount is less than the reality.

P 11 Much discussion took place on es revenue Guest House, which is t significantly lowered due to non participation and different organization century training perst ataires by e partners to insecurity and disorder of the previous two years ; To do this the Board recommends that the direction of the IMCK educate partners to patronize our servic es for the IMCK is the only structure on the city of Kananga, which meets at least the standards care, accommodation (water permanently ; of electricity ; internet etc.)

P 12 Regularization of the retirement situation is very important for retirees ; the debt of more than \$ 48,000 to be paid to the INSS is too large, so the management is obliged to

reduce this debt and regularize the situation of retirees within a short time.

Before closing this part Mr. Larry gave the information that the rehabilitation of Guest house will resume shortly with Mr. Antonio and he asks the management to help him so that this work evolves quickly.

It is through this information that the economic-financial report was adopted.

XIV . PRESENTATION OF THE 2018 BUDGET

17 - CAN - 045 - The Chief Accountant of IMCK presented in detail the 2018 budget planning according to the departments below ,

1. The Higher Institute of Medical Technology ; ISTM Tshikaji : 1 71,617, \$ 86
2. Tshikaji Medical Technical Institute ITM Tshikaji : \$ 140,499
3. The Good Shepherd Hospital indexing ophthalmology ; Pax recipes and the dental clinic : \$ 687,483

After reading the following amendments and comments were detected ;

1. The IPRs of the ISTM and ITM agents must be deposited at the IMCK for the latter to deposit them to the services concerned. : INSS, INPP, ONEM, IPR etc.
2. You have to make an account plan according to the reality of the IMCK :
3. The \$ 4000 contribution from the SANRU account must be reduced from the budget because it will close soon :
4. Reduce the amount of MBF grant because the fees it uses are those that the PCUSA makes available for monitoring ;
5. Management must make a great effort to reduce penalties and budgeted fines by applying the merger of two payrolls .

Before closing, the direction of the IMCK recalled the non-execution of the decision of the Board in May 2016 from the sale of carcasses are old rolling stock and other bad amortized states (one since 2010 , the decision to make a statement of technical and financial place to present to the finance committee and this one will analyze and make the decision before executing the recommendation concerned by the direction was taken.

X V IMPLANTED PROJECTS AND THE 2018 ACTION PLAN

17 - CAN - 046 - Speaking, the Director of IMCK spent in some already revised e im planted projects and presented the action plan of the IMCK for the year 2018. After reading the amendments and following dditional r s were retained ;

1. Rehabilitation of the Medicine and Surgery Women's Pavilion whose work has started and suspended due to lack of funding from the IMA but will resume if the IMA mandate is extended ;
2. An observation was made with regard to those responsible for receiving funds in the Action Plan ; members suggested that some subordinates responsible activities are associated with members of management, for example associate chaplain regarding charity and activity spiritue l l e and to associate the technicians in the matter for a good management.
3. With regard to the assignment of people solely for cleanliness external to the hospital ; the CA recommends the use of boys and girls from rooms and sometimes use the laborers for this purpose as needed ;
4. The CA finds that it is necessary to buy the tractor for weeding that to buy the mower ;
5. Members have asked the management of the IMCK seek partners that can support the external rehabilitation of PAX and some internal parts (administrative office, reception, the various offices of Doctors consultations, ophthalmology, ENT, the diabetic department, the patient observation rooms and the PAX pharmacy , for a good harmony

because a part is rehabilitated in an isolated way namely the part of laboratory, the dentistry and the maternity which will be inaugurated soon.

With these observations, the IMCK 2018 Action Plan was adopted.

XVIII I PRESENTATION OF COMMITTEE WORK

17 - CAN - 50 - The committee work was presented and they were adopted after amendments, readjustments and clarifications on certain points.

A. Staff Commission

1. PEOPLE HAVING DOUBLE CONTRACT WITHIN IMCK

The Board found that within the IMCK there are workers who have double contract ; they are paid by the state and at the same time by the IMCK . D o nc to regularize this situation in accordance social legislation an agent can not have two s salary thus the AC recommends that the direction of the IMCK of first harmon ize the merger of two of e payroll sheets before deciding aware of the next meeting in May

2. THE REPLACEMENT OF WORKERS OF THE ERRORS, RETIREES AND REVOKS IN IMCK ?

The Board recommends the direction of IMCK directly replace the worker and hence it does not take the point of view e Council except in the case of Doctor which concerns only the Board of Directors.

3. THE FILE OF MASTER Albert ASSISTANT TO ISTM CLAIMING THE PAYMENT OF HIS FEES TO IMCK WITH BAREAU OF KANANGA

Board members have followed attentively the file of the assistant Albert Nkashama designated verbally by the direction of the IMCK to defend him in case of a judicial problem since 2013 and who has brought to justice the IMCK to claim his rights ; since IMCK management has showed good faith to pay with a deposit of \$ 2500 to \$ 10,000 was already paid, we mend the direction of the IMCK to overcome to complete this debt and the current officials avoid so to work ting to protect the institution against abuse adm inistrative and judicial. These application no further t in the direction of ending the cont rat Maitre Albert in ISTM soon as the debt is discharged.

4. THE DOSSIER OF DOCTOR MBANZA AND DOCTOR Mireille

The Board noted with regret that since 17 October 2016 during the period of unrest in Kasai Dr. Mbanza does not practice within the IMCK and wants to stay in Kinshasa despite the good faith to affect his wife to perform the function of Physician Dealing with them until then they did not respond favorably . Thus Board members asked the leadership of the IMCK to terminate their contracts in accordance with the statute and regulations of the IMCK.

5 . THE DEMAND EMPLOYMENT OF Dr. Jacques TSHIASUMA AT BMI K

The Board analyzed the record of this Doctor and noted his performance within the IMCK as a Physician Dealer

5. IMCK DIRECTOR 'S REQUEST FOR THE AMENDMENT OF CERTAIN ARTICLES OF THE COMPANY REGULATION

With regard to the request for the amendment of certain articles ; the CA asks management to produce a document in collaboration with the delegation workers' union and the labor inspectorate before presenting it to the Board of Directors for approval.

B FINANCE COMMISSION

1. APPROVAL OF THE ITM BUDGET

The Board found that the budget presented for the GTI is unbalanced that is to say the liability and the asset does not correspond ent ago exceeded \$ 290 in assets therefore recommends that the management of the IMCK r ESee this situation with the management of ITM.

2. THE NON INSPECTION OF PENSIONS BY THE INSS

The Board found that IMCK owes a debt to INSS of \$ 34,668 since 2012, and, from this debt INSS does not want to support retirees IMCK of 2015 and 2017. To do this the Board recommends officials IMCK seek strategies that can enable them to clear or reduce dett in e ting for retirees are covered under social legislation.

3. MANAGING LOADS OF ISTM AGENTS ; ITM AND DENTAL CLINIC BY HBB

The members of the Board of Directors have found that since the creation of the IMCK all IMCK revenues were centralized and had a common fund . But there was a moment when some departments asked for the financial autonomy of their revenues in particular : ITM, Dental Clinic and ISTM . B ut some of their personal expenses are borne by the hospital alone it is : social assistance, the payment of the end of career allowance ; care in medical care and transport of staff ; it weighs a lot on the hospital as well The AC recommends that


the direction of the IMCK to get in touch with the labor inspector ting to find a point of view e will guide us in decision making because all workers have signed the contract with IMCK and not with a department of IMCK.

4. EMPLOYING PERSONNEL WITHIN IMCK

The board found that 10 months ago workers did not have their salaries due to the multiple causes and necessarily by the insufficiency of revenues realized and by the insolvency of some subscribers after having followed the treatment. Given this situation, the Board recommends that IMCK management make an effort to reduce the number of months of staff overpayment, and the Extended Collection Board to do its best to recover the funds after the processing.

In addition, the Board asks the management to increase contact with various authorities of the place in order to find the means of payment of unpaid bills

of military, police, militia and population.

THE DIFFICULTY OF CARING FOR SICKNESS FROM CONFLICTS

Due to its social nature which is to enable access to care for the poor population, the IMCK an ecclesiastical institution works with biblical philosophy based on compassion. It has people who take care of it free of charge in medical care and other category is supported by the partner specifically the PCUSA through its member parishes via MBF.

Eligible for this last category is any patient (male, female, old, child, widow or married) who meets the criteria of being unable to pay the bill and without support. With this category the MBF had put a fund of \$ 65,000 for a whole year or \$ 5416.6 per month from June 2017 to June 2018

But two years ago, the IMCK went through a difficult period following the troubles caused by the militia of the Grand Chief in the Congolese government whose IMCK was at the center of these troubles. Pendant cette période l'IMCK a constaté qu'il a perdu au total un montant de 48790.98\$ des factures non payées ; soient \$21726,95 pour le traitement des militaires et policiers, \$12495,95 pour le traitement des malades amenés à l'hôpital sur demande du gouvernorat et des autorités politico administratives de la province et \$14568,08 de la population amenée dans un état de choc par les membres de leurs familles.

Vu que les recettes réalisées pour ces dernières années sont sensiblement baissées suite aux différentes barrières érigées avant d'arriver à l'hôpital par les militaires et policiers qui défavorisent les malades à fréquenter nos services , l'IMCK se retrouve en difficultés de continuer à servir les malades issus de ces conflits et qui n'honorent pas l eurs factures , seulement ceux qui répondent aux critères de charité sont considérés.
